Currently, for children who study until the first March 31 after turning 18, child support is paid six times a year in even months, each time paying every two months.

This child support, based on Article 21 Clause 1 of the Child Support Law, if the parents apply, can be used to offset debts such as kindergarten childcare, meal fees, afterschool childcare fees or late childcare fees

For guardians who agree to use the Child Allowance for the payment of unpaid nursery fee or lunch fee

Please fill out the "Request Form for the Collection of fees for nursery schools (nursery fees and lunch fees) in relation with the Child Allowance" **on the back side**, and have it submitted to the nursery school which you attend or the Childcare Division together with the application documents.

- \* The amount of child allowance may change depending on the number of children and the amount of income of the guardian.
- \* If there are siblings, please fill them all out in one application form.
- \* If you have not yet applied for a child allowance, submitted the status report for your child allowance, or filed a tax return, please complete the procedure as soon as possible.

As per the provisions of Article 22, Paragraph 2 of the Child Allowance Act, it is permitted to allocate the Child Allowance to nursery fees (special collection) without request from the guardian. In case of special collection, we will inform you separately.
